**ALTERNATIVE PROSECUTION PROGRAM ORDER**

4. The defendant agrees to comply with all the terms and conditions of the Alternative Prosecution Agreement.
5. The defendant agrees not use or be in possession of any illegal substance, cannabis, prescription medication of another, or use any substances designed to have the effects of an illegal substance, or be in the presence of anyone using or in possession of such substances.
6. The defendant agrees to not consume alcohol, and agrees to submit to Breathalyzer testing.
7. The Circuit Court Clerk's Office is ordered to immediately release the bond posted and direct the funds toward Alternative Prosecution Program fees and/or restitution, unless otherwise directed by the Court.
8. The defendant agrees, by signing this Order, to waive formal notice of any future court dates and instead agrees to appear in court as directed by the State's Attorney's Office.
