MISDEMEANOR ALTERNATIVE PROSECUTION PROGRAM ORDER

With all parties to the Misdemeanor Alternative Prosecution Program Agreement ("Agreement") being present and the Court having addressed and fully admonished the defendant in open court concerning the Agreement and as to constitutional rights,

**The Court HEREBY FINDS AND ORDERS:**

- B. The parties agree that there  is  is not restitution owed by the defendant in this case.

- D. The signed original of the Agreement has been filed with the Court on this date, executed by the defendant and, if represented by counsel, his/her attorney.
- E. The defendant agrees he/she has read the Agreement, understands its terms and agrees to comply with all the terms and conditions of the Agreement.
- F. The Circuit Court Clerk's Office is ordered to immediately release any bond posted and direct the funds toward the usual and customary court costs and fees associated with court supervision cases for a criminal misdemeanor in which the Compliance Unit is assigned, actual restitution, anti-crime program restitution fee, and/or drug/alcohol testing fee, unless otherwise directed by the Court.
- G. The defendant agrees to waive, and does by signing this Order waive formal notice of any future court dates and instead agrees to appear in court as directed by the State's Attorney's Office.
- H.
